PRO-VISION[®] (the company) warrants to the original retail end user of the above listed digital video recorder, 30 minute time delayed shutoff module, video camera(s), external microphone and video joiner device (the product) that should this product, under normal use and conditions, be proven defective in material or workmanship within 60 months from the date of original purchase, such defect(s) will be repaired or replaced with new or reconditioned product (at the company's option) without charge for parts and repair labor.

To obtain repair or replacement within the terms of this warranty, the product is to be delivered with proof of warranty coverage (e.g.: dated bill of sale), serial number on product, specification of defect(s), Return Merchandise Authorization Number clearly marked on the exterior of the shipping container and transportation prepaid to the company's main office shown above. A Return Merchandise Authorization Number (RMA number) may be obtained by calling 800.576.1126. Failure to obtain a RMA number and to clearly mark that number on the exterior of the shipping container may cause your shipment to be refused.

This warranty does not apply to any product or part thereof which, in the opinion of the company, has been damaged through alteration, improper installation, mishandling, misuse, neglect, or accident. Opening the housing of the digital video recorder, 30 minute time delayed shutoff module, video camera(s), external microphone or video joiner device will void the warranty. Removal of the serial number will void the warranty. If product is sent back for warranty evaluation without sufficient packing for product protection during shipping, warranty will be void. **The extent of the company's liability under warranty is limited to the repair or replacement provided above, and, in no event, shall the company's liability exceed the purchase price paid by the purchaser for the product.**

This warranty is in lieu of all other express warranties or liabilities. **Any implied warranties, including any implied warranty of merchantability, shall be limited to the duration of this warranty.
